DMFC Membership Application Information

The DMFC has legal obligations to properly account for the payments you make to the Club. Under GDPR (General Data Protection Regulations) DMFC also has legal obligations relating to holding your personal data and sharing it with other parties. DMFC publishes a Privacy Policy which can be read and downloaded from the [Club Website](#).

An important element of GDPR is that your consent to the Privacy Policy must be sought and reaffirmed from time-to-time. However, since without your consent to the Privacy Policy the Club would be unable to carry out any of its important functions on your behalf, the basis for holding and processing elements of your personal data is **Legitimate Need**, and for that reason your consent to the Club Privacy Policy is a condition of membership, as is your agreement to be subject to the Club Constitution and Club Rules which are also published on our website.

For the reasons stated above it is necessary for every member of DMFC to complete **and sign** a hard paper copy of the current DMFC Membership Application Form when joining or renewing their membership, and only by doing so will your membership be accepted. Blank forms are available for anyone unable to print a copy at home. As your signature on this form is confirmation of your consent and agreement to what are in fact legal documents - (the DMFC Privacy Policy, the Club Constitution, and Club Rules), applicants are advised to read and download copies of these documents for personal reference.

The law requires all operators of model aircraft of 250g-20Kg weight, plus ALL which carry a camera, to register annually with CAA, for which there is a small registration fee. BMFA members may complete their CAA registration along with their BMFA Membership via the BMFA membership portal. SAA Members must renew directly with CAA via the CAA website. All Members must affix their Operator ID to every model they fly. Full details of the CAA requirements are available via the CAA Link on the Club Website [Useful Links](#) Page which also provides links to the BMFA and SAA websites. The law also requires all flyers of model aircraft over 100g AUW to obtain a Flyer ID by completing the online competency test on the CAA website or the Registration Competency Certificate (RCC) test on the BMFA website. All model flyers must have a current valid CAA Flyer ID in order to fly legally and this must be entered on the Application Form. (CAA Registration requirements may be updated from time to time and applicants should refer to the [CAA Website](#) for the latest regulations).

BMFA Members must join or renew their BMFA membership using the [BMFA online membership portal](#) or by telephoning the BMFA Head Office, and may complete their CAA Operator registration at the same time via the same method. The registration of those members who initially registered for their Operator ID independently with the CAA will expire on the anniversary of their initial registration and they must therefore again re-register directly with the CAA. SAA members must renew their annual SAA membership directly with the [SAA](#).

Please remember that it is your membership of BMFA or SAA which provides the Third Party Insurance, so it is vital to join or renew your membership of BMFA or SAA as otherwise you will not be permitted to fly.

The annual DMFC subscriptions and fees for the current year are as follows:-

DMFC Membership Annual Subscription - £60.00 DMFC Initial Joining Fee - £30.00
DMFC Junior Membership Subscription - £10.00 Junior initial Joining Fee - £15.00 (Only if aged under 18)
Non-Flying Annual Membership - £10 - non-flying members do not require BMFA/SAA membership nor CAA Operator or Flyer IDs and do not pay a joining fee. (Enter "Non-Flying" in the Application Form where necessary).

There are fee reductions for those joining later in the year - (See [DMFC Subs & Fees](#)). Payment may be by cheque payable to Dumfries Model Flying Club and sent to the Club Treasurer along with your signed Membership Application Form. Alternatively payment may be by Bank Transfer in which case the transfer must state your name so that the Club Treasurer can match your payment to your Membership Application or Renewal Form. Members who pay by Bank Transfer also have the option of sending their Membership Application Form electronically too.
